#### 4. Missed Components of Term Work:

There is no deferred Midterm test examination. In the event that a student misses the midterm or any course work due to illness then an official medical note will be required. If an excused absence is approved, then the percentage weight of a legitimately missed midterm examination will be transferred to the final examination (see Section E.3 of the University Calendar).

#### 7. Examination Policy:

Examinations will be closed book. Non-programmable calculators during examinations will be allowed:

Calculator Feature: the capability to perform calculations electronically on user-entered numerical data without the capability to employ pre-stored or user-entered formulae. This feature is provided by the most elementary calculator, permits the elementary arithmetic operations (addition, subtraction, multiplication and division) and possibly the trigonometric, hyperbolic, exponential and logarithmic operations.
