<sup>1</sup> A series of case studies will be completed in class on Mar 18, 20, Apr 1, 3, and 8. These are worth 1% each.

<sup>2</sup> Presentations will be split between Mar 25 and 27. Participants will have an opportunity to practice on Mar 11 and 13, for completion marks. Presenter order will be assigned early in the term, and dates cannot be deferred or rescheduled. These presentations will take place in-person during scheduled class time.

<sup>3</sup> Five quizzes will be held tentatively Jan 15, 22, 29, Feb 5, 12. All quizzes carry the same weight. While dates may vary, students will be given notice the lecture period before should the quiz be postponed (quizzes will not be moved up in the schedule). Quizzes take precedence over out-of-class activities from other classes. There will be no deferral option available. Quiz grades will be established by the best 4 of 5 quizzes.

<sup>4</sup> Three reading and analysis exercises will be assigned, due online tentatively Jan 19, Feb 2, Feb 16, although dates may vary.

<sup>5</sup> This is a synchronous, physically co-located exam that takes place in-class. It takes precedence over out-of-class activities from other courses. There will be no deferral option available.

<sup>6</sup> The term paper will be submitted online by the end of the semester. There will be prior opportunities for students to receive feedback on their draft as well as advice and approval on their topic.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

#### 4. Missed Components Of Term Work:

In the event that a student legitimately fails to submit any online or in-person assessment on time (e.g. due to illness, domestic affliction, etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date, or possible exemption and reweighing of components. If an excused absence is approved, options for how the missed assessment is dealt with is at the discretion of the coordinator or course instructor. Some options such as an exemption and pro-rating among the components of the course may not be a viable option based on the design of this course.

There is no deferred midterm examination in this class. In the event that a student misses the midterm and an excused absence is approved, the weight of the midterm examination will be distributed among the Presentation and Term Paper.

Quiz grades will be established by the best 4 of 5 quizzes. Thus, if a student misses a quiz and an excused absence is approved, their grade will be distributed among the remaining 4 quizzes.

Because the Exercises and Term Paper are online submissions with ongoing work, late submissions will have a mark deduction of 10% per day.
