### **COURSE CALENDAR STATEMENT:**

Readings will normally be selected according to genres, such as Epic, Tragedy, Comedy and Lyric. This course may be repeated for credit.

### **COURSE DESCRIPTION:**

This course will focus on selected *Odes* of Pindar (*Olympian* 2, 7, and 11; *Nemean* 4; and *Isthmian* 3, 4, and 7) as specimens of lyric 'epinician' poetry (victory odes).

### **COURSE LEARNING OUTCOMES**

Upon successful completion of this course, students should have honed their skills at reading, translating, and interpreting a classical Greek text. They will be introduced to the history of the epinician genre and the cultural and political background of Pindar's career.

### LEARNING RESOURCES

There is a required textbook for this course, which contains the Greek text of the *Odes* of Pindar specified above as well as a grammatical commentary.

### LEARNING TECHNOLOGIES AND REQUIREMENTS

There is a D2L site for this course to which documents will be posted from time to time. Students may also submit their assignments via the Dropbox on the same D2L site.

### **CLASS SCHEDULE**

Most seminar sessions throughout the term will be devoted to translating Pindar's *Odes* together in class, at a pace to be set by the participants. The due dates for the bi-weekly Assignments are listed under "Assessment Components" below.

### ASSESSMENT COMPONENTS

Assessment of the student's Course Grade will be divided among five Assignments and an optional inclass Presentation. The Assignments will typically consist of translated passages from Pindar with short grammatical, literary, or historical commentaries on those passages. The in-class Presentation, which the student may opt to present in lieu of one of the assignments, will address a topic related to Pindar's poetry or to his historical background or to the role of epinician odes in ancient Greek athletic contests. Topics will be posted on D2L later in the term. The presentations will take place in late November or early December.
