#### **COURSE DESCRIPTION:**

Was the Democracy of Ancient Athens like modern democracy? What is the "Spartan Mirage"? Why is hope evil? Was Augustus the first Roman Emperor? What is the origin and meaning of the phrase "Bread and circuses"? This course will explore these questions and more in an introduction to themes in Greek and Roman history, society, religion, and culture. We will also explore ancient writings and material culture to give you an immersive introduction to the worlds of Greek and Roman Antiquity.

# **Hybrid In-Person and Online Asynchronous Format:**

This course will comprise both **in-person sessions** and **online content**, via Desire2Learn (D2L) and Zoom. To best succeed in the course, students are encouraged to attend all synchronous class sessions and to participate in the asynchronous learning tasks (i.e. tasks students complete at their own pace such as watching lecture videos, completing readings, completing assessments items such as quizzes, etc.) using the D2L learning environment.

#### **COURSE LEARNING OUTCOMES**

This course will introduce students to the major themes and events in Greek and Roman history and culture and encourage students to develop critical thinking skills when learning about historical cultures.

Upon successful completion of this course, students will be able to:

- Identify and describe the major periods of Greek and Roman history
- Recall and discuss significant individuals, facts, events and dates
- Recall and discuss significant developments in Greek and Roman society and culture
- Define important terms and concepts
- Engage with primary source materials
- Develop their ability to critically analyze various aspects of life in Ancient Greece & Rome

#### **ASSESSMENT COMPONENTS**

#### **Group Discussions:**

There will be 5 group discussions, cumulatively assessed to comprise 15% of students' overall grade. Students will be divided into discussion groups and each Monday students will engage in instructor-facilitated discussion based on students' textbook readings. Each discussion group will complete a discussion worksheet during class time and submit the worksheet at the end of class. Discussion worksheets will be graded based on active participation and demonstration of engagement with assigned readings. Please note that the classroom is a safe environment. Freedom of expression and diversity of opinion are encouraged in group discussions. However, all communication must be constructive and respectful.

#### Quizzes:

There will be 6 quizzes, cumulatively assessed to comprise 60% of students' overall grade. Quizzes will be posted on D2L, at 2:00pm on the day listed on the course schedule. Test availability will close at 2:00pm on the next day. Students may begin the test at any time within the window of availability. Quiz questions will focus on material covered in the lectures of the previous week. Quizzes are 30 minutes in length, and students will receive 45 minutes to complete the quiz (30 minutes = 50% extra time due to online format). Quizzes are open-book, and students may reference their lecture notes during the quiz, but no other materials should be used.

# **Group Project:**

The group project will comprise 25% of students' overall grade. Students will be divided into groups and work together on the project over the course of the semester. There will be 3 assessment items associated with the group project: 1) **The Group Project Worksheet** (worth 5% of total grade) will require students to select a topic and project type (from a list of choices provided by the instructor), reflect on their choices, and assign group roles. 2) The **Group Project Outline** (worth 10% of total grade) will require students to provide a detailed outline of their chosen project and identify key primary and secondary sources that will inform their work. 3) **The Completed Project** (worth 10% of total grade) will be due on the last day of class. Group projects will be assessed on both form and content. **Please note:** Students will be given instructor-facilitated time to work on group projects during class time. However, group projects will also require students to complete work outside of class time as well.
