COURSE CALENDAR STATEMENT:

A survey of ancient, medieval and Renaissance humorous prose, with reference to their roots in classical literature.

COURSE DESCRIPTION:

This course focuses on the close reading and analysis of literary texts, while also considering them within the historical and sociological contexts in which they were written. We will consider the different functions of humour within varying societies, as well as the literary and rhetorical techniques by which

writers create humor. Students will engage in interactive class discussions, critical reading and writing, and creative production.

*COURSE LEARNING OUTCOMES

Upon successful completion of this course, students will be able to:

- 1. Analyze and discuss satirical and humorous works of literature from the ancient, medieval and early modern ages.
- 2. Use primary sources and secondary academic sources to investigate the use of humor.
- 3. Understand the different functions of literary humor in specific social and historical contexts, particularly when used to express minority points of view or experiences of those who do not belong to majority groups.
- 4. Use oral and written communication to express their own academic ideas, as well as experiment with other creative forms of communication.
- 5. Comprehend differences and continuities between past historical cultures and our own.
