DESCRIPTION:

This course offers an introduction to the art and architecture of ancient Italy and its expansive Roman Empire from approximately 900 BCE to 330 CE. This chronological time frame sets the stage for an examination of early Roman art and architecture through the lenses of Greek and Etruscan influences. We will then move into the era of the Roman Republic, when Italy was unified under Roman rule and the armies of Rome began to make their presence felt in other Mediterranean cultures. The course continues with an analysis of the art and architecture of Imperial Rome under the reigns of Roman emperors from Augustus to Constantine.

Please note that *PowerPoint* presentations do form a major component of the lectures, making regular attendance important for success in the course. You are responsible for **ALL** of the material discussed in class, including the visual material, as well as the information provided within the required and any assigned supplementary readings. Examinations are based upon all of these components.

A detailed syllabus will be supplied for you on the first day of class outlining required readings and important dates. In addition there will be a *Blackboard* site constructed for this course.

COURSE REQUIREMENTS:

1. **Research essay, Due April 9, 2010, 8-10 pages (Times 12 font)** typed and double-spaced with references bibliography and illustrations. Each student **must** inform the instructor by **February 12th** of the chosen topic. Late essays will be penalized 1/2 letter grade per day (to be taken off after the grade of the paper is assigned).
2. **Midterm Examination February 22, 2010** 35%
3. **Final Examination (to be scheduled by the Registrar)** 30%
