# **COURSE CALENDAR STATEMENT:**

Early Greece from the late Bronze Age to the Persian Wars.

# **COURSE DESCRIPTION:**

The classical period is regarded as the apex of ancient Greek history, and on it the spotlight is inevitably shone when speaking of the achievements of the ancient Greeks. However, the classical period was preceded by several formative centuries which laid the groundwork, making these achievements possible. The primary aim of this course is to study the main historical developments of these formative centuries, from the Bronze Age to the period just before the Persian Wars (roughly 3000-500 BC), a time-period collectively known as "Early Greece".

Learning will occur in a hybrid manner. There will be synchronous meetings on Wednesdays at 1 pm to discuss topics and follow up with the students' progress. Lectures can be listened to at any time in D2L, documents are also posted on D2L.
