COURSE CALENDAR STATEMENT:

History of the Greek world from the Persian Wars to the conquests of Alexander the Great.

COURSE DESCRIPTION:

This course focus on key elements and events of classical Greece. The evolution of institutions and political thinking will also be discussed. Students will engage with sources, including – but not limited to – ancient texts and will be exposed to some of the important disagreements that can be found in scholarly research. Through class discussions, critical reading and assignments, the students will be encouraged to reflect on such the elements discussed in class and to formulate their own opinion.

Upon successful completion of this course, students will be able to:

- 1. Understand the influence of the major events on the development of Greek cities during the classical period
- 2. Understand the institutions in Greek cities
- 3. Reflect on the development of political thinking
- 4. Use critical thinking toward theories concerning classical Greece
- 5. Analyze passages from ancient authors

Midterm (25%): Students will be asked short and middle length development questions regarding the material covered from week 1 to 3.

Aligned Course Learning Outcomes: 1, 2, 3 and 5

Articles review (20%): Student will be assigned two scholarly articles presenting opposite views on a same subject covered in class. They will summarize and explain the views of both authors. They will also take position on the matter and provide justification for their position by using knowledge learned in class and in the readings. The marking sheet and criteria for assessment are posted in D2L.

Aligned Course Learning Outcomes: 2, 3 and 4

Group presentation: Students will be separated in teams of four and assigned, as a group, either a fictive private or public case, with a specific position to defend. As a group, they will need to write a speech to defend that position by using typical structure and typical arguments used by the Attic orators. On the day of the presentation, the speech will be delivered in front of the class by one of the members of the group (more members can participate to the presentation if "witnesses" are used). Every group will be set against another group defending the opposite position. Once both groups have delivered their speech, the rest of the class (representing the Athenian jury) will vote for a winner.

- Individual part (15%): Each student of the group must choose two speeches of an Attic orator. The student will analyze the structure of the texts and identify the different types of arguments used in the text. Students of a same group must choose different speeches.
- **Group part (15%):** As a group, the students will write one speech to deliver on the day of the presentation. They can use the speeches which were analyzed by the students as models. One student will be in charge of delivering the speech. Other members of the group can participate to the presentation as witnesses. Students will be evaluated on the quality of the speech, the performance during the delivery, and the general appreciation of the jury.

Aligned Course Learning Outcomes: 2, 3 and 5

Final exam (25%): Students will answer short and middle length development questions regarding the material covered from week 4 to 7. They will also answer one long development question covering matters explored through the whole course.

MISSED OR LATE ASSIGNMENTS

EXPECTATIONS FOR WRITING

All written assignments will be assessed partly on writing skills. This includes surface correctness (grammar, punctuation, sentence structure, etc.) but also general clarity and organization. Students will be encouraged to formulate personal opinions. While doing so, it is expected from them to use knowledge from ancient sources to sustain their opinion.
