COURSE CALENDAR STATEMENT

An introduction to Greek literature from Homer to the Hellenistic Period.

COURSE DESCRIPTION

What is an emotion? Did the ancient Greeks feel the same emotions as us? How did they express emotions in their writings? What words and imagery did they use? This course will examine various genres of literature (such as epic, drama, medical writings, and philosophy) in order to gain a better understanding of the emotional lives of the ancient Greeks.

COURSE LEARNING OUTCOMES

By the end of the course, students should be able to:

- define what an emotion is and engage with some of the current theories about emotion in writing
- explain some of the challenges of the study of the history of emotions
- analyze and discuss ancient Greek texts in translation (with a particular focus on the emotion expressed therein) while developing active reading skills
- apply various theories and approaches to the study of emotion in the ancient Greek texts
- compare and contrast ancient and modern expressions of certain emotions through a critical analysis lens
- independently find and use primary and second sources in their research on ancient emotion
- collaborate successfully with others in a team

Journaling

Six journal entries of 200 words for each unit, based on the required readings. There will be some guiding questions to help you along the way. Completing the journal entry before the due date will also enhance classrooms discussions. Journal entries will be graded on active reading, content, and clarity.

Engagement

Six engagement self-assessments for each unit. There will be a rubric provided for students to self-assess their engagement with the course via preparation and participation.

Team Presentation

A 10-minute team presentation based on the team project. The presentation will be graded on content, organization, and presentation skills.

Team Project

A final project whereby teams complete a written or video essay on a chosen topic. The project will be graded on content, organization, sources, citations/bibliography, and mechanics. Teams will also need to complete a team contract and team evaluation (5%).

MISSED OR LATE ASSIGNMENTS

There is a late penalty of -5% per day; however, life happens so please email me **as soon as possible** if you believe you won't be able to meet a deadline or have already missed one. Requests will be assessed on a case-by-case basis.

Accommodations for foreseeable events (e.g., varsity events, religious holidays, etc.) should be requested well in advance.

Please note: no bonus or separate make-up assignments are available.

GRADING

A numerical mark will be given for each course requirement. A letter grade will be assigned as a final grade on the following number and letter grade scheme, usually used within the Department of Classics and Religion:

Your final grade for the course is the sum of the separate assignments. It is not necessary to pass each assignment separately in order to pass the course.

Writing skills include not only surface correctness (grammar, punctuation, sentence structure, etc.) but also general clarity and organization.
