COURSE DESCRIPTION:

Supervised research in the Nickle Numismatic Collection in Nickle Galleries, Libraries and Cultural Resources, University of Calgary.

This course will provide a directed experiential learning with the coins from the Nickle Numismatic Collection in the of Ancient Numismatics for advanced ANME/GRST students. Students will learn to do advanced research in this field with the end result of the creation of a lengthy piece of scholarship.

Students will arrange their schedules in consultation with the curator.
