COURSE DESCRIPTION:

This course will provide a directed reading opportunity in the field of Ancient Egypt for advanced ANME/GRST students. Students will learn to do advanced research in this field with the end result of the creation of a lengthy piece of scholarship.

Upon successful completion of this course, students will be able to:

1. Demonstrate ability to create an advanced research question.
2. Learn to do advanced research in Near Eastern studies.
3. Create an advanced piece of research and writing.
