### **COURSE CALENDAR STATEMENT:**

This course is a continuation of the learning begun in Latin 201.

### **COURSE DESCRIPTION:**

This course uses an incremental approach to move you further towards reading Latin texts. Through weekly exercises and quizzes, students will continue to learn the basics of Latin grammar and syntax and to build a core vocabulary. Students will also have an opportunity to identify their own primary

objectives in their study of Latin, apply what they have learned, and reflect on the value of their learning to their personal objectives.

### **COURSE LEARNING OUTCOMES**

Upon successful completion of this course, students will be able to:

- 1. Demonstrate mastery of material covered in the first twenty-two chapters of the textbook.
- 2. Demonstrate an improved grasp on English grammar and vocabulary.
- 3. Appreciate an increased affinity for the Romance languages (e.g., French, Italian, Spanish).
- 4. Apply some techniques for analysing the structure of a language.
- 5. Articulate some awareness of the connections between language, culture, and history.
- 6. Appreciate the value of healthy learning strategies (e.g., continuous study, incremental learning)

# ASSESSMENT COMPONENTS

**Homework Assignments (15%):** Most Mondays you will submit a brief homework assignment (always in your homework notebook!) on the newest chapter's material. This will give you a chance to get some feedback before the chapter's quiz, and to submit any questions that you want addressed. These assignments will be corrected and returned on the next class, but will not be evaluated for correctness, only completion. [Aligned Course Learning Outcomes: 1]

**Quizzes (24%):** Most Friday classes will begin with a short quiz that focuses on the previous chapter's material. These are intended to keep you up to date in the course. They will tend to get more difficult as the term progresses. The best 8 scores (out of 10) will each count for 3% of your final grade. [Aligned Course Learning Outcomes: 1]

In-class Preparedness and Participation (10%): You are expected to be an engaged learner in the course, so I will evaluate your participation (be present, and be attentive) and your preparedness to contribute, especially on the Wednesday practice classes, when the class work collectively to strengthen everyone's knowledge. [Aligned Course Learning Outcomes: 1]

Introductory and Self-reflection Assignments (5% total): At the beginning of the course, students will identify personal objectives associated with the course. At the mid- and end-points of the course, students will revisit and update those objectives and reflect upon their own progress as well the application of what they have learned to their own interests. This will also be an opportunity to reflect upon the course itself and offer feedback to the instructor. The two self-reflection assignments will be very short written assignments, and will be submitted through D2L. [Aligned Course Learning Outcomes: 2, 3, 4, 5, 6]

**Midterm Exam (20%)** and **Final Exam (26%)**: the exams will test you thoroughly on everything learned to date. They will include questions on grammatical analysis, translation, composition, and comprehension. [Aligned Course Learning Objectives: 1, 4, 5]
