COURSE CALENDAR STATEMENT:

Classical or Biblical Hebrew language; the development of ability in the critical reading of ancient texts. No attempt will be made to provide any competence in medieval or modern Hebrew.

Course Hours: 3 units; (3-0)

Antirequisite(s): Credit for Religious Studies 300 and 207 will not be allowed.

COURSE DESCRIPTION:

An introduction to reading Biblical Hebrew, including grammar and vocabulary. Emphasis will be on developing students' competence in reading and writing the Hebrew letters, and on familiarizing students with common vocabulary and basic grammar. Learning materials will include authentic Biblical texts, and practical exercises in reading, writing, and grammar. Student participation in Zoom sessions will be strongly encouraged as an essential component of practice. This course is designed for students with no previous knowledge of the language.

ONLINE:

This course will take place **online** via Desire2Learn (D2L) and Zoom. All lectures will be synchronous (real-time) via Zoom. The D2L learning environment will be used to provide extra resources and activities outside the live sessions.

COURSE LEARNING OUTCOMES

Upon successful completion of this course, students will be able to read Biblical Hebrew texts and understand basic components of their vocabulary and grammar. Students will be able to write with Hebrew letters.

A student who is absent /unable to take the test in the 24 hour period for legitimate reasons must inform the instructor immediately and an alternative course of action may be considered.
