#### **COURSE CALENDAR STATEMENT:**

This course is an examination of the evolution of ancient 'pagan' (Greek and Roman non-Christian) and early Christian religions, exploring their similarities, differences, and interactions, and situating them in their social, economic, cultural, and political context. #### **COURSE DESCRIPTION:**

This unit will consider continuities and ruptures in the practice of religion from the pre-Christian Roman Republic to the early Christian Middle Ages in central Italy. We will look at the material evidence *in situ* of the religious cult of the Greco-Roman superhuman Hercules and the depictions of Christ in early and medieval Christianity, assessing the meaning of their modes of humanity and association with the divine. We will consider social and religious funerary and memorial rituals that highlight similarities and differences between pre-Christian and Christian religious and social practices. We will study the literary and political culture of the Greco-Roman world through the writings of the Roman poet Ovid and the early Christian theologian Augustine of Hippo.

#### **COURSE LEARNING OUTCOMES**

1. Acquired an understanding of pre-Christian religion and early medieval Christianity in western Europe.

2. Acquired through site visits an excellent understanding of the material culture and its implications regarding both pre-Christian religions and early medieval Christianity.

3. Acquired through reasoned arguments based on evidence, an informed perception of religious beliefs and practices within their historical and social contexts of Greco-Roman religion and politics and early Christianity.

4. Acquired skills through written assignments, site visits, presentations, and class discussion of how to reflect upon, present, analyse and evaluate complex ideas and arguments.

5. Develop an understanding of how other countries and people present their historical legacies and identities and how this may reflect on one's own history and identity.

## ASSESSMENT COMPONENTS

There are three assessment components that all align to learning outcomes 1,2,3,4. These consist of an oral presentation, short essay, and a group presentation. Criteria for assessment will be discussed in class and posted on D2L.

10 May 2023 Each student will give a short oral presentation.	Each student will give a short oral presentation (3-4 minutes) of initial experiences and observations of religious culture of central Italy. (Class participation mandatory.)	15%
15 May 2023 Submit via Dropbox a 600- word essay.	Assignment 2: You are to write a 600-word essay comparing and/or contrasting the Roman cult of Hercules to early Christian devotion to Christ. OR Write a 600-word essay comparing and/or contrasting non- Christian and Christian funerary and memorial rites.	35%
25-26 May. On-site group presentations.	Assignment 3: A ten-minute spoken dialogue between Ovid and Augustine outlining their views on transformation. Each group must submit their dialogue in written form via Dropbox immediately after their presentation. (Class participation mandatory.)	50%

## MISSED OR LATE ASSIGNMENTS

If you miss a required component of the course, you must contact me in writing within 24 hours to discuss options to submit for that component. Assignments submitted after the deadline may be penalized with the loss of a grade (e.g.: A- to B+) for each day late.

## GRADING

A numerical mark will be given for each course requirement. A letter grade will be assigned on the following number and letter grade scheme, usually used within the Department of Classics and Religion:

Your final grade for the course is the sum of the separate assignments. It is not necessary to pass each assignment separately in order to pass the course.

Sources used in written assignments must be properly documented. Please be sure to consult a manual of style for your written assignments. If you need recommendations, the latest edition of any of the following would be fine: *The Chicago Manual of Style; MLA Handbook; Turabian: A Manual for Writers*.
