COURSE CALENDAR STATEMENT:

A seminar course examining topics, personalities and movements in Christianity from its origins to its modern and contemporary developments.

COURSE DESCRIPTION:

Covering the period from the early church to the early fifteenth century, this unit will investigate various ascetic practices found in the premodern world. We will address the following questions: Why did some Christian men and women want to practice celibacy? Why was the preservation of virginity and the avoidance of marriage significant for women wanting to pursue a religious life? What does this tell us about religious, social and historical perceptions of holiness, sexuality, and the body? Why are holy women remembered for their fasting, vigils, and bodily mortifications more than men? Overall we will investigate how and why gender and the human body are key aspects in understanding ritual and devotion in Christianity. In some cases we will bring the discussion into modern/contemporary discourse. Students will engage in class discussions, presentations, produce a student anthology, an annotated bibliography, write an essay, and present and record a lecture.

COURSE LEARNING OUTCOMES

Upon successful completion of this course, students will have:

1. Acquired an understanding of the history of the body and its relation to Christian theology.

- 2. Acquired through reasoned arguments based on evidence, an informed perception of the actions and motivations of religious practices within their historical and social contexts.
- 3. Acquired skills through written assignments, presentations and class discussion of how to reflect upon, present, analyse and evaluate complex ideas and arguments.
