COURSE DESCRIPTION:

This is a research driven course. The general topic is the Influence India had on other cultures from 300 BCE to 1600 CE. Lectures will provide a survey on the relations between India and Central Asia, China & beyond, Greece, medieval Europe, Rome, and S.E. Asia. Students are required to select a research topic within the parameters of the course and submit a final term paper (see below). A proposal of the research topic for the paper of one page is required. Students will make an oral presentation of their findings according to a published schedule. Class participation is important in determining one's grade. The focus is on History but within this, there are many possibilities for research. Examples are: Art History, Religious History, Numismatics, Linguistics, etc.

Learning Outcomes and Core Competencies:

Upon successful completion of this course, students will be able to:

1. Have a working knowledge of India as a major influence in the world.
2. Determine a research project
3. Ability of conduct research and discriminate between resources.
4. Ability to present research findings in both an oral and a written format.
5. Ask questions and participate in discussions on specific topics.

Course Research expectations:

Students must determine a research project topic on the History of India's influence outside of India from the years 300 BCE – 1600CE.

Students must submit a one-page proposal for their project which will include a thesis statement or topic explanation, and a working bibliography of 5 sources. (see schedule)

Students must present to the class an oral presentation on their research and the conclusions reached. Further, the presenter must field questions from the audience. Students not presenting should be present for each presentation and ask questions.

Student must submit a research paper: 10 pages (title page does not count), double line space, 12pt font (Calibri or Times New Roman). The paper should have an expanded section on the thesis or topic question, the body of the text, conclusion, end notes, and a full bibliography. Please use the Chicago Style for your paper. Submit paper by due date via email as an attachment using .docx file type.
