Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected. - o Secondary student outcome: Understand the computer technical specifications taught in class in order to perform a rudimentary evaluation of a list of specifications that may be included in an actual computer advertisement.
- o Secondary student outcome: Describe common technical concepts so that students can at least demonstrate a rudimentary level of computer literacy.
