Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. - Describe and summarize the roles of programming and computing in a broader context of topics that may include scientific and non-scientific computing, data storage and analysis, established sub-disciplines of computer science, history of computing, or social and philosophical issues.
