¹ There will be five assignments. Each assignment has equal weightage. The due dates are: July 09, July 16, July 23, July 30 and Aug 08 by the end of the day at 11:59 PM. There will be three grace late days. For example, you can submit assignment 1, assignment 2 and assignment 3 one day late without any deduction. Or you can submit assignment 1 and assignment 2 on time, while assignment 3 can be three days late without any deduction. After three days, an assignment will be accepted with 30% late penalty for every single late day. No assignment will be accepted after six days (including 3 grace late days). The last assignment should not be submitted later than August 10, 2023.

² We will use TopHat for the participation marks. Tasks/questions will be assigned using TopHat. You can solve those questions either during the class or anytime after the class. The task will remain available to solve in TopHat till August 08, 2023. The grade for this will be counted towards the participation marks. You should finish all TopHat questions on the last day of class to the max.
