A calculator may be used for tests or examinations. No other aids will be permitted.

In the event of a missed midterm, students must fill out the provided online form within 48 hours of the original exam to register to write a deferred midterm. The deferred midterms will be scheduled exactly one week after the original, and students must write the deferred exam to receive marks for the missed component. Students may defer **at most one** midterm during the semester. Weight will only be shifted to the final exam in exceptional cases (hospitalization, etc.) with sufficient supporting documentation.

- a. **Term Work:** The student should present their rationale a s effectively and as fully as possible to the Course coordinator/instructor within **ten business days** of either being notified about the mark, or of the item's return to the class. If the student is not satisfied with the outcome, the student shall submit the Reappraisal of Graded Term work <u>form</u> to the department in which the course is offered within 2 business days of receiving the decision from the instructor. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
