Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

## 4. Missed Components Of Term Work:

In the event that a student legitimately fails to submit any online or in-person assessment on time (e.g. due to illness, domestic affliction, etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date, or possible exemption and reweighing of components. If an excused absence is approved, options for how the missed assessment is dealt with is at the discretion of the coordinator or course instructor. Some options such as an exemption and pro-rating among the components of the course may not be a viable option based on the design of this course.

All graded work, except for the final exam, is optional: If a student does not hand in an assignment or participate in a midterm test, then the weight of that assignment or test will be shifted towards the weight of the final exam. For example, if an assignment with weight 5% is not handed in by the deadline, then the weight of that assignment will automatically be reduced to 0, and the weight of the final exam will be increased by 5%.

There will be no repeat midterm tests and no individual assignment deadline extensions, unless granted for the entire class.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
