¹ The demos will be individually scheduled with each team in the period November 27 to December 1. The code of the corrected system (if corrections are needed) has to be submitted on the given date. The grade will be based on the failed test examples in the demo and the performance of the fixed system.

Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. [The Final Examination Schedule](#) will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

In order to deal with the grade A+ that unfortunately does not scale in the grade point equivalents, the following rule will apply: an A+ as final letter grade will be awarded to every student who has an A in all three components.

A student must pass the final exam to earn D or higher in the course!
