<sup>2</sup> We will use TopHat for the participation marks. Tasks/questions will be assigned using TopHat. You can solve those questions either during the class or anytime after the class. The task will remain available to solve in the TopHat for one week. The grade for this will be counted towards the participation marks.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
