Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Percentages will be used to compute a numerical grade, between 0 and 100, using the weightings for components given above. This will be rounded up to the nearest integer. This integer, between 0 and 100, will be used to compute a letter grade using the above table. The instructor may have some input to finalize the boarder grade letter at his discretion, in particular, to convert a grade of "A" to an "A+" based on outstanding performance in all components of the course.

The final exam for this course will be designed to be completed within 2 hours.

The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
