3. **Grading:**

Unless explicitly stated otherwise by the instructor, all assignments are to be completed individually by each student. The instructor will use automated code similarity detection system. All cases of plagiarism and any other academic misconduct will be investigated and reported to the Faculty of Science.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.
