Each of the above components will be given a letter grade using the official university grading system (see section F.1.1). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

The quizzes are synchronous (all students write at the same time) and designed to take up to 40 minutes to complete, but students will be given additionally 50% of the time making the total time 60 minutes to allow for technical and other issues.

The exam is synchronous (all students write at the same time) and designed to take 75 minutes to complete, but students will be given 115 minutes to allow for technical and other issues.
