Credit for both Computer Science 502[CPSC502] and any of 503[CPSC503], Software Engineering for Engineers 599[ENSF599] or 591[ENSF591] will not be allowed. Students intending to complete a research project in a specific area of computer science should register in the version of Computer Science 502 corresponding to that area, if such a course is available. Other students should register in Computer Science 502.01. Permission to register in Computer Science 502 is generally given only to students with a minimum GPA of 3.30 over the last 15 FCE. When demand exceeds capacity, registration in Computer Science 502 is limited to students in Honours programs in Computer Science.

Research proposal	15%
Related work list and critiques	15%
Interim report	10%
Final report	30%
Final presentation	30%

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a percentage score. The student's average percentage score for the various components listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows;
