- Permission to register in Computer Science 502 is generally given only to students with a minimum GPA of 3.30 over the last 15 FCE.
- When demand exceeds capacity, registration in Computer Science 502 is limited to students in Honours programs in Computer Science.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course

letter grade.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
