**Prerequisite(s):**

**Note(s):**

- a. Credit for both Computer Science 502[CPSC502] and any of 503[CPSC503], Software Engineering for Engineers 599[ENSF599] or 591[ENSF591] will not be allowed.
- b. Students intending to complete a research project in a specific area of computer science should register in the version of Computer Science 502 corresponding to that area, if such a course is available. Other students should register in Computer Science 502.01.
- c. Permission to register in Computer Science 502 is generally given only to students with a minimum GPA of 3.30 over the last 15 FCE.
- d. When demand exceeds capacity, registration in Computer Science 502 is limited to students in Honours programs in Computer Science.

3. **Grading:**

The University policy on grading and related matters is described in [F.1](#) and [F.2](#) of the online University Calendar.

In determining the overall grade in the course the following weights will be used:

Component(s)	Weighting %	Date
Research proposal	15%	Sept 28
Related work list and critiques	10%	Nov 9
Interim report	15%	Dec 7
Final report	30%	April 12
Final presentation	30%	March 24 - April 12

Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

If the student is not satisfied with the outcome, the student shall submit the Reappraisal of Graded Term work form to the department in which the course is offered within 2 business days of receiving the decision from the instructor. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
