Other students should register in Computer Science 502.01. Permission to register in Computer Science 502 is generally given only to students with a minimum GPA of 3.30 over the last 15 FCE. When demand exceeds capacity, registration in Computer Science 502 is limited to students in Honours programs in Computer Science.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
