2. **Requisites:**

**Prerequisite(s):**

Computer Science 313 and 457 and consent of the Department.

**Antirequisite(s):**

Credit for Computer Science 527 and 627 will not be allowed.

3. **Grading:**

The University policy on grading and related matters is described in [F.1](#) and [F.2](#) of the online University Calendar. In determining the overall grade in the course the following weights will be used:

Component(s)	Weighting %
Assignments	50%
Take-home midterm	20%
Take-home final exam	30%

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Rounding will be performed if necessary using the usual method. The instructor may convert a grade of "A" to an "A+" at his discretion for outstanding performance in all components of the course.

Bear in mind that a grade of D+ or below will result if 50% or better on the overall assignment mark and 50% or better on the overall exam mark (final and midterm combined) is not achieved.

**Students will be required to sign a legal form in order to take this course. Strict lab protocols will be in effect; failure to adhere to these protocols will result in an automatic "F" grade in the course.**

- Know a range of techniques used in malware implementation; know a range of techniques used in anti-malware implementation
- Be able to analyze simple malware
- Be able to write code to detect, identify, and remove simple malware
- Have a hands-on understanding of how malware is created
