1. Course: CPSC 573, Visualization and Analytics - Fall 2023

This course introduces deeper tools, skills, and techniques for collecting, manipulating, visualizing, analyzing, and presenting a number of different common types of data. With a data life-cycle perspective, we will discuss data collection and preparation as well as the usage of data in a decision-making context. The course will also introduces techniques for visualizing and supporting the interactive analysis and decision making for a variety of different types of data, including text, networks, and geographic datasets. The class will also focus on critical thinking and good analysis practices to avoid cognitive biases when designing, thinking, analyzing, and making decisions based on data.

Course Objectives

- **Visualization Types.** Students should be aware of a variety of specific domain areas in information visualization such as text visualization, tree and network visualization, maps, multidimensional data visualization, physical visualization, and casual/personal visualization.
- **Visualization Assessment.** Students should be able to interpret, critique, and deconstruct visualizations created by others.
- **Exploratory Data Analysis.** Students should be able to conduct exploratory data analysis on real, complex data sets by creating new visualizations in tools like Tableau and Google Colab.
- **Applying Machine Learning.** Students should be able to apply basic machine learning approaches to cluster, classify, and transform datasets.
- **Presentation.** Students should be able to create visual presentations of their analytic results, including dashboards, graphical reports, presentations, and stories.
- **Data and Ethics.** Students should be aware of the ethical implications of data collection and analytics. Students should be able to identify problematic data collection and experimentation practices, and be able to think and talk critically about the challenges associated with collecting, analyzing, and interpreting data with real-world consequences.

To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In addition, adjustments may be made to the modality and format of assessments and deadlines, as well as to other course components and/or requirements, so that all coursework tasks are in line with the necessary and evolving health precautions for all involved (students and staff).
