- 1. Design practical human-robot interfaces. Gain insight on the physical nature of robots, and its implications on the design of effective human-robot interfaces.
- 2. Explain and reason with core concepts from human-robot interaction (HRI), design, psychology, and cognitive science such as social HRI, situational awareness, zoomorphism, anthropomorphism, robotiquette, android science, and the uncanny valley.
- 3. Prototype human-robot interfaces using low-level, mid-level, and high-fidelity prototyping techniques, implementing your design with various robots such as the Pioneer P3-DX, Sony Aibo robot dogs, Parrot Bebop drones, and Nao humanoid robots.
- 4. Demonstrate design communication skills to present user research and HRI design concepts to elicit criticism and feedback â€" including hand sketching, prototyping, scenarios, as well as verbal, written, and video presentation.
- 5. Gain knowledge and insight from fields closely related to HRI, such as robotics, remote sensing, design, human factors, cognitive science, Computer-Supported Cooperative Work (CSCW) and psychology.
