Students will meet three times per week for a 50-minute Zoom meeting, which will be recorded and posted online for posterity. Each meeting will revolve around the presentation and discussion of one recent research paper on developing, deploying, attacking, or analyzing various privacy-enhancing technologies (PETs). In most cases, the meeting will be led by a student; in a small number of instances, pre-recorded presentations by the authors of these papers may be presented in lieu of a synchronous lecture.

There are no formal prerequisites for this course; however, students will benefit from a background in cryptography, discrete mathematics (probability theory, linear algebra, and abstract algebra), and theoretical computer science.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student’s grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.
