3. **Grading:**

Team report on plans for system	15%
Implemented learning system	30%
Individual system report	15%
Final oral exam	40%

Each of the above components will be given a letter grade using the official university grading system. The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

Please note that in order to pass the course, you have to achieve a passing grade in the weighted combination of individual system report and final exam!

A grade of A+ will be awarded, if the student got an A in each of the four components.
