3. **Grading:**

Team report on plans for system	15%
Implemented learning system	30%
Individual system report	15%
Final online oral exam (scheduled individually between April 15 and 24)	40%

Each of the above components will be given a letter grade using the official university grading system (see [section F.1.1](#)). The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

In order to pass the course, a student has to achieve a passing grade in the weighted combination of individual system report and final exam!

An A+ will be awarded if a student has an A in all 4 components.
