Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

### 4. Missed Components Of Term Work:

Students will be assigned to groups at the beginning of the semester. A student can only miss two online lab meetings as the group work builds each week and their absence directly impacts the progression of other members of their group. Should a student miss more than two meetings,

1. they need to reach out immediately to the course coordinator. The student will then be removed from the group and be required to complete work (give details) on their own should they wish to progress in the course.
2. The students will receive a maximum grade of B in this component or course.
