Course Description:

The primary purpose of this course is to introduce students to microeconomic theory and how it relates to the real world. The material includes an introductory approach to the concepts of consumption, production and the role of government in a mixed market economy. Emphases will be placed on important economic issues such as gains from trade, supply and demand, (and its role on price determination) price elasticity, production and costs, market structures, market failure and the distribution of income. We also explore factor markets, which includes wage determination and the supply and demand for labour.

Course Objectives/Learning Outcomes:

This course will provide the student with a theoretical and practical background on how economic agents (e.g. consumers, producers and governments) interact with each other in order to predict a certain outcome. We then investigate whether this outcome is socially efficient and what tools are available to make markets and society better off. One important aspect of economics is the realization that there are trade-offs (or opportunity costs) when decisions are made, whether these decisions are made from individuals, firms or governments.
