The Assignment, the Midterm Test, and the Final Exam are marked on a numerical (percentage) basis and then converted to letter grades. The course grade is then calculated using the weights indicated above. As a guide to determining standing, these letter grade equivalences will apply:

A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

The assignment, which consists of several questions, is due at the *beginning* of the lecture on the due date. Solutions to the assignment will be posted on the Desire2Learn website at that time. This means that late assignments cannot and will not be accepted. I do not accept e-mailed assignments. I do not accept assignments slid under my office door.

The Midterm Test will be held in the classroom during regular lecture hours. The Final Exam will be two (2) hours in length and will be scheduled by the Registrar's Office. There will be no multiple choice questions on the Midterm Test and the Final Exam. The use of a simple calculator during the test and the final exam will be allowed. Graphing calculators, cell phones, and any type of computer are not permitted.

The assignment, the test, and the final exam are intended to be challenging (they are "*tests*" of your understanding of the material). You are encouraged to consult with your classmates when working on the assignments. The solutions you submit must, however, represent your own work. Taking credit for someone else's work is something for which I show zero tolerance.

Notes:

1. Students should be aware that no "make-up" midterms will be given. Any student who finds it necessary to miss the midterm must notify the instructor in advance and produce a valid medical certificate or other required documentation in order to have the weighting adjusted. This adjustment will result in the final exam counting for 70% of the final grade and the assignments counting for 30% of the final grade.
2. Examinations will not be given prior to the scheduled date.

3. **Answers to the midterm test, the assignment and the final exam questions must make use of equations and diagrams wherever possible. Numerical questions require numerical answers.**
4. **Students will not be given extra time to complete tests and exams.**
5. Students should be aware of the academic regulations outlined in The University of Calgary Calendar.
6. **The use of cell phones for any purpose in class is prohibited. Computers may only be used for note-taking purposes.**
7. Students seeking reappraisal of a piece of graded term work should discuss their work with the instructor within 7 days of work being returned to class.
