Course Description:

This is a course in microeconomic theory. Microeconomics uses theory to determine how people/firms will most likely interact independently and with one another. The results of said theory help governments/policymakers determine the most appropriate way to intervene in society. In this course, we will explore the basic theory of microeconomics. The main topics we will cover are consumer theory (demand), producer theory (supply), and the equilibrium that arises from their interaction. Many of the concepts covered in this course should be familiar; ECON 201 should have covered a number of concepts we will discuss, however, our treatment of these concepts will be more technical. Calculus is not required for this course (and will not be used), but high school level algebra will be used extensively. In particular, you must be able to solve a system of two equations and two unknowns. Microeconomic theory is fundamental to the study of economics, and I have a responsibility to ensure that you are well-versed in the basics. Because of this, the course is structured such that you must attain a strong understanding of basic principles and procedures in order to pass. You will be provided with an ample amount of questions, readings, and office hours to ensure you have every opportunity to attain said understanding.

Course Learning Outcomes:

Upon successful completion of this course, students will be able to:

1. Understand the principles that serve as the foundation of economic reasoning and analysis.
2. Understand how equilibrium is reached through the interaction of actors at the individual and aggregate level.
3. Conduct comparative statics on models studied in class.
4. Evaluate the strengths, limitations, and value judgements imposed in various economic models.

Online Delivery:

Lectures:

Lectures will be delivered online at the Registrar scheduled times and delivered using ZOOM. The lectures will be recorded and subsequently posted to D2L.

Tutorials:

Students are expected to attend “virtually” the tutorial sections to which they have been assigned. Tutorials will be offered online, typically using ZOOM, but can involve moderated discussion boards and curated delivery of alternative online resources. During the tutorials, the TA will discuss pre-assigned questions and additional material relevant to the course that is not covered in lectures.

A passing grade on any particular component of the course is not required for a student to pass the course as a whole.

If a student’s letter grade on the final exam exceeds their midterm(s) letter grade, the weight of the midterm(s) may be transferred to the final exam at the discretion of the instructor. The student must have written the midterm(s) or provided supporting documentation for the absence(s) such as a medical note or statutory declaration.

Course material dealing with a particular assignment will typically be covered in class at least 7 days before the assignment is due; thus, assignments can be completed at any time up to and including the due date. Given these factors, only situations where someone can document illness or domestic affliction for an extended period (i.e., the entire 7 days prior to the due date) would possibly warrant shifting the assignment weight to the final exam. Furthermore, technical problems can be expected to occur with computer systems (and internet availability) so it may be a good idea to not wait until the last minute to submit your assignment.

The midterm exam(s) is take-home exam(s) designed and intended to be completed in 50 minutes. The exam(s) will be OPEN book. The exam(s) will be available on D2L. Student will download the exam from D2L, complete the exam, scan it, and submit using Dropbox in D2L. Student will have 50% time extension to complete the exam, at a time of your choosing, within a 24-hour period determined by the instructor.

The exact 24-hour time period for the in-class midterms on Feb 26 and March 26 will be announced at least one week in advance

The final examination will be take-home, comprehensive, and scheduled by the Registrar. Students will download the exam from D2L, complete the exam, scan it, and submit using Dropbox in D2L. Student will have 50% more time to complete the exam, at a time of their choosing, within the 24-hour period that begins 24 hours before the end date of the Registrar's scheduled final exam for this course. The exam is designed and intended to be completed in two hours. The exam will be OPEN book.

Tests and exams **WILL NOT** involve multiple choice questions.

All other course components will also be accessed, submitted, and returned through D2L.

If a student cannot write their final exam on the date assigned by the Registrar's Office, they need to apply for a deferred exam <https://www.ucalgary.ca/pubs/calendar/current/g-6.html>. Under no circumstance will this be accommodated by the Department.
