Course Description:

Operation of the natural gas industry in North America. Economics of exploration, development, production, marketing and transportation of natural gas. Impact of government regulations and deregulation.

Course Objectives/Learning Outcomes:

Students will conduct literature reviews and use economics to understand issues in natural gas supply (including exploration, storage, transportation, pricing, and local distribution) and demand (including environmental externalities, and substitutes for natural gas use).

Economics 201 and 203

GROUP PROJECTS: You will be involved in two group projects, each with a different randomly assigned group, and each worth 10% of your grade. For each project you will be assigned to join an interest group (e.g., natural gas consumers, a local distribution company, natural gas producers, or an environmental lobby). You will be tasked with providing a position on an activity: the first will be shale gas

development and the second will be an LNG terminal. Using the academic literature you will provide convincing evidence supporting your position. Your individual grade will be affected if your teammates report that you shirked. Attendance is mandatory at group meetings.
