## **Course Description:**

The course is designed to provide an introduction to the study of money, banking, and financial markets. In the context of a unifying, analytic framework, it organizes students' thinking about the structure of financial markets, the foreign exchange markets, financial institution management, and the role of monetary policy in the economy.

#### **Course Learning Outcomes:**

After completing this course, students will know

- How financial markets (such as those for bonds, stocks, and foreign exchange) work and affect their everyday life.
- The central role of financial institutions (banks, mortgage loan companies, credit unions, insurance companies, and mutual fund companies) in the workings of the economy.
- How banks are managed and banking is conducted to earn the highest profits possible.
- The importance of central banks to the health of the financial system and the economy.
