#### **Course Description:**

The course is designed to provide an introduction to the study of money, banking, and financial markets. In the context of a unifying, analytic framework, it organizes students' thinking about the structure of financial markets, the foreign exchange markets, financial institution management, and the role of monetary policy in the economy.

#### **Course Learning Outcomes:**

The objective is to help students understand how financial markets (such as those for bonds, stocks, and foreign exchange) and financial institutions (banks, mortgage loan companies, credit unions, insurance companies, and mutual fund companies) work and affect their everyday life. Another objective is to provide a thoroughly up-to-date treatment of the latest developments in monetary policy.

Tests and exams WILL involve multiple choice questions.

The midterm exam will be take-home and is designed and intended to be completed in 75 minutes online in D2L. The exam will be OPEN book. Student will have three hours to complete the exam, at a time of their choosing, within a 24-hour period determined by the instructor. The exact midterm date and 24-hour period will be announced at least one week before.

The final examination will be take-home, comprehensive, and scheduled by the Registrar. The exam will be OPEN book. The exam is designed and intended to be completed in two hours online in D2L. Students will four hours to complete the exam, at a time of their choosing, within the 24-hour period that begins 24 hours before the end date of the Registrar's scheduled final exam for this course.

All other course components will also be accessed, submitted, and returned through D2L.
