Course Outline:

This course explores how individuals behave in a social context. The objective is to contribute to our knowledge of various social problems using tools of economic analysis. Emphasis will be put on individual's incentives that may lead to social problems. We will study policy design and policy evaluation commonly proposed to deal with social problems. Topics regarding the distribution of income (poverty, inequality, mobility), social environment (discrimination, crime, addiction, multiculturalism), and provision of social insurance (health care, education, pensions, unemployment insurance) will be covered in class.

The following is a tentative list of topics we will discuss. If there are any topics you would like to see covered, please let me know. A detailed outline will be provided the first day of class. You should be comfortable with simple algebra and graphs.
