Course Description:

This course will use economic analysis to develop our understanding of social issues. Using the economic model, we will explore how individuals behave in social context and evaluate policies addressing various social issues including discrimination, crime, health care, income inequality, and poverty.

Course Learning Outcomes:

- 1. Enhance proficiency in employing and interpreting economic methods and models.
- 1. Introduce the application of economic metrics for growth and development, emphasizing broader socio-economic and distributional indicators.
- 2. Explore economic research on the causes and consequences of income inequality, presenting diverse theories of economic allocations and their philosophical foundations.
- 3. Acquire understanding of various poverty measures and economic theories explaining poverty's origins, encompassing a grasp of poverty components and their associated theories.
- 4. Understand theories of taste-based and statistical discrimination, recognizing the repercussions of each type, and explore discrimination theories from other disciplines.
- 5. Gain insight into economic theories shaping criminal behavior and the judicial system; develop familiarity with the Canadian criminal justice system.
- 6. Develop the concept of externalities concerning environmental issues and develop an understanding of methods employed to alleviate environmental problems.
- 7. Develop the theory of human capital as it relates to population health and cultivate familiarity with single-payer and private insurance healthcare systems.
- 8. Cultivate research skills encompassing the formulation of research questions, selection of appropriate methodologies, literature review, and effective communication of research findings, including professional skills honed through peer review exercises.

This course will emphasize writing and analysis.

- Policy reports will be one to two-page written assignments evaluating a given policy using concepts and methods from class. Policy reports are tentatively due at midnight on January 18, February 1, February 15, March 7, March 21, and April 4. Late policy reports will not be accepted.
- The term project will be a research project based on a social issue of your choosing. This will involve a written term paper (5-10 double-spaced pages), a 3–5-minute video presentation, and participation in a peer review process. The term paper and video presentation are due by midnight on Monday April 22nd, 2024. Students must receive a passing grade on the term paper to receive a passing grade in the course.

• There will be no final exam.
