I will compute your final grade using the following two methods:

Method 1 -	Midterm Exam	30%
	Assignment	20%
	Final Exam	50%

Whichever of these methods yields the higher grade will then be utilized.

Each student must work in a group, consisting of either 3 or 4 students, to complete the assignment. Only one assignment will be submitted by the scribe of each group. The assignment is due at the beginning of the lecture on the due date. Late assignments will not be accepted.

The midterm exam will be held in class on the date indicated. The time and location of the final exam, which will be two hours in length, will be scheduled by the Registrar's Office. Exam questions will not consist of multiple choice questions. The use of a calculator during exams is not permitted.

The midterm exam, assignment, and the final exam are marked on a numerical basis. The grades are then added using the weights indicated above. As a guide to determining standing, these letter grade equivalences will generally apply:
