Each student must work in a group, consisting of either 3 or 4 students, to complete the assignment. Failure to comply with this requirement will result in a grade of "0" being recorded. Only one assignment will be submitted by the scribe of each group. The assignment is due at the beginning of the lecture on the due date. Late assignments will not be accepted.

The midterm exam will be held in class on the date indicated. The time and location of the final exam, which will be two hours in length, will be scheduled by the Registrar's Office. Exam questions will not consist of multiple choice questions. The use of a simple non-programmable calculator during exams is permitted. Business calculators, scientific calculators, graphing calculators, etc., are nor permitted.

The midterm exam, assignment, and the final exam are marked on a numerical basis. The grades are then added using the weights indicated above. As a guide to determining standing, these letter grade equivalences will generally apply:
