Course Description:

This course emphasizes the basic tools that economists employ to evaluate and determine the effects of taxes. Particular attention is paid to tax fairness and to the incentive effects of taxation on behavior such as the effect on labour supply, saving, investment, and tax evasion among others. Each segment of the course consists of institutional facts and the development of the economic theory required to understand the issues, followed by a summary of the relevant empirical evidence.

Course Learning Outcomes:

- (a) Understand and appreciate the history and rationale of tax systems in developed countries.
- (b) Familiarity with the institutions and rules surrounding different taxes in Canada. Examples include:
 - Payroll taxes
 - Personal income taxes
 - Value-added taxes
 - Corporate income taxes
- (c) Understand and appreciate key principles, theories and ideas in the economics of taxation literature including:
 - The economic theory of tax evasion and tax enforcement
 - The determinants of who bears the economic burden of a tax
 - The key factors that drive the efficiency cost of taxes
 - The optimal design of taxes that balance equity and efficiency considerations, including optimal income taxes and optimal commodity taxes.
- (d) Know and understand the key findings in the empirical literature that studies the behavioural effects of taxes.
- (e) Be able to analyse and critique current policy proposals in the area of taxation using theoretical and empirical tools developed in class.

(f) Develop skills necessary to conduct research. This includes (i) learning how to come up with a research question, (ii) finding suitable data for empirical research questions, and (iii) conducting a statistical analysis of the data.

Course Outline:

A more detailed list of topics and readings will be provided at the beginning of the course. Broad topics covered may include:

- 1. A mathematical review of microeconomic theory and welfare economics.
- 2. Tax Incidence.
- 3. Efficiency costs of taxation.
- 4. Optimal commodity taxation.
- 5. Taxation and labour supply.
- 6. Optimal income taxation.
- 7. Taxation and savings and investment.
- 8. Environmental Taxation.
- 9. Tax Policy.

This course takes the prerequisites seriously. In particular, a solid understanding of intermediate microeconomic theory (Econ 357) is required. Calculus will be employed throughout the course. I will review the appropriate techniques as necessary.
