Course Description

General equilibrium treatment of the gains from trade, comparative advantage and trade patterns provides a basis for examining topics such as: trade policy under imperfect competition, trade policy and the environment, trade policy and economic growth, and preferential trading arrangements.

Course Objectives/Learning Outcomes

The objectives and learning outcomes in this course are developed using two distinct, although not necessarily separate, approaches: (i) theoretical and (ii) policy.

From a theoretic perspective, we extend the technical expertise acquired in Econ 357 to develop *trade models* under various assumptions including different market structures (e.g. maximize objective functions subject to specific constraints). These models identify gains/losses from trade, the emergence of trade patterns along with distributional effects (e.g., transfer of income from one sector of the economy to another). In this context, students hone and improve their technical skills – mathematical, graphical, and intuitive – and recognize the merits and short-comings of the various models.

The reality, however, is that *trade policy* is often driven by factors other than “economics” and theoretical trade models only provide one insight to the policy process. Political, social, environmental, and other considerations all play an important role in the formulation of trade policy. We examine trade policy from these perspectives and use specific examples to highlight the importance of each. In this

context, students recognize the important distinction between theory and practice. Students are highly encouraged to present a case study in class (see Course Requirements/Assessments below); those who present a case gain important experience in the collection, analysis, and presentation of data and knowledge.

Some of the specific course competencies and outcomes include:

- i. critical thinking through demonstrated quantitative literacy, including working with data, statistics, and algebra;
- ii. critical thinking through demonstrated written literacy;
- iii. independent thinking through demonstration of the ability to explain and analyze economic/political arguments for logical consistency and sequence of argument;
- iv. communication through use of mathematical language and graphical presentation as well as through sequential verbal and written argument;
- v. information evaluation through the ability to use economic models and specific micro/macroeconomic tools.

Course Requirements/Assessments

- (i) There are five, *non-cumulative quizzes* worth 8% each to be held on the following *Wednesdays* in this Winter 2016 semester: January 20, February 3, February 24, March 9, and March 23. Each quiz will be approximately 50 minutes in length and may consist of theoretical, mathematical, graphical, applied, and/or “readings” questions. ***Make-up quizzes will not be given.*** In cases of documented illness, documented family emergency, or documented religious observance, the weight of the quiz will be equally divided between the remaining quizzes (or allotted to the final examination in the case of quiz #5).
- (ii) There are five, *non-cumulative assignments* worth 5% each to be held on the following *Mondays* in this Winter 2016 semester: January 18, February 1, February 22, March 7, and March 21.

Assignment must be submitted at the beginning of class – no exceptions or pleas for mercy will be entertained.

- (iii) A *final exam* worth 35% will be written during the final exam period as scheduled by the registrar. The *final exam is cumulative* and is 2 hours in length as scheduled by the Registrar's office. More information will be provided towards the end of the term. **NOTE:** Students may reduce the value of the final exam to 18% by presenting a case study to class as a group project; the minimum group size is 4, maximum is 5. The nature and framework of the presentation will be discussed in the first lecture but, in essence, groups *select and present a trade dispute* that has gone through the World Trade Organization's (or other trade agreements') dispute settlement mechanism. The last two weeks of lectures will be reserved for these presentations.

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows. The student shall discuss the work with the instructor within 15 days of being notified about the mark or of the item's return to the class; no reappraisal of term work is permitted after the 15 days. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the next 15 days. The reappraisal of term work may cause the grade to be raised, lowered, or to remain the same.
