#### **Course Description:**

This course builds on the introduction to electricity markets course to more advanced topics, including: design of electricity markets; transmission regulation, investment and pricing; ancillary services demand, procurement and regulation; retail competition; and distribution systems and distributed generation. It is intended to provide advanced knowledge of electricity markets for students to pursue further research in the field.

#### **Course Learning Outcomes:**

After completing this course, students will know:

- i. How electricity markets are organized in North America
- ii. Market design options and challenges
- iii. How electricity and ancillary services are procured and traded
- iv. How externalities are priced or regulated in electricity markets
- v. Retail rate design for electricity consumers

#### **Course Outline:**

This course delves deeper than Econ 329 (Economics of Electricity Markets) into the specific options and challenges facing electricity markets today. In particular, the course will focus on market design, regulation, and retail rate design in terms of efficiency and equity implications.

The general structure of the course will be Monday and Wednesday lectures, with most Fridays being either a 25 min quiz followed by 25 min discussion of the quiz, or a component of the Energy Market Game that will be played throughout the course. Students are expected to actively participate in the course, including in an **Electricity Market Game** played throughout the course.

A term research paper on a broad topic related to Canadian electricity markets will provide students the opportunity to dive deeper into a subject of their choosing.
